## **Discipline Costs**

## Effective January 1, 2023

Pursuant to action by the State Bar's governing board in January 2011 and May 2012, the costs assessed for disciplinary matters are adjusted annually to account for changes in labor and other resource costs. The adjustment is calculated by combining 40% of the year-on-year percentage change in the Consumer Price Index<sup>1</sup> with 60% of the year-on-year percentage change in the Employment Cost Index for Management, Professional and Related Occupations<sup>2</sup>. For 2023, the adjustment is an increase of 4.61%.

Effective January 1, 2023, the costs assessed for disciplinary matters will be as follows<sup>3</sup>:
