Beginning December 07, 2020, the State Bar closed its offices in San Francisco and Los Angeles to the public. The State Bar has taken this measure out of an abundance of caution and in an effort to protect staff and the community due to the COVID-19 pandemic. Consequently, the State Bar Court courtrooms remain closed to the public, effective December 07, 2020, and until further notice the State Bar Court lobby and filing window will be closed to the public. The State Bar Court will continue to accept deliveries and filings at the security desk from the hours of 10:00 a.m. to 4:00 p.m.

The State Bar Court will continue to conduct what it deems to be essential business in order to fulfill the primary purposes of discipline, which includes protection of the public, the courts, and the legal profession; maintenance of the highest professional standards; and preservation of public confidence in the legal profession. Unless otherwise ordered, remote court events, including but not limited to trials and oral argument, will continue to be held as scheduled.
