State Bar Court Portal User Guide

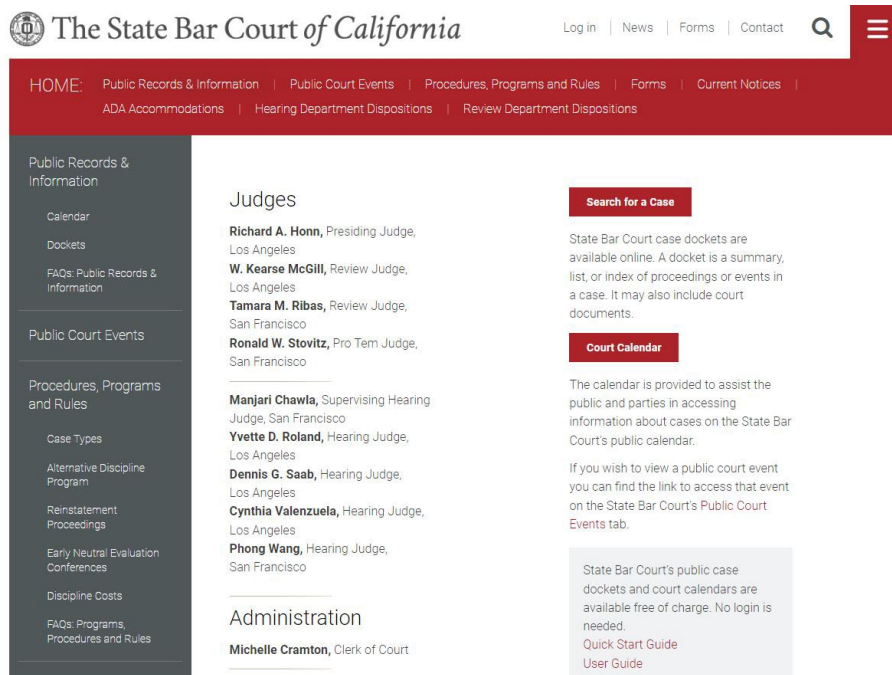
The State Bar Court Portal provides online access to case dockets and documents for cases filed since 2000. Access is free. Registration is not required, you do not need to create an account or log in.

Accessing the Portal

You can access the portal from the State Bar Court home page.



You can either “**Search for a Case**” or search for a “**Court Calendar**,” from the buttons on the right.

The portal will display in a new window.

Search for a Case

Use the “**Search for a Case**” function to find dockets and records for a specific case or cases for a specific attorney, respondent, petitioner, or applicant.

- For public cases filed on or after Feb. 1, 2019, documents are available online.
- For cases filed since 2000 through January 31, 2019, only some documents are available online. To request additional documents, submit a [written request](#).
- To request certified copies, or for additional information, please see the [Public Records & Information webpage](#).

Search for a Case

State Bar Court case dockets are available online. A docket is a summary, list, or index of proceedings or events in a case. It may also include court documents.

When entering a name, the format must be **last name, first name**. Both entries are required for a complete search. The name must be spelled correctly.

Tip: If you are uncertain that you have the attorney’s correct name, you can use the [Attorney Search Feature on the State Bar website](#), which offers the option to include similar spellings.

Note: At this time, the advanced filtering options are unavailable.

If you know the case number, you can enter it in the same field. For cases filed on or after February 7, 2019, case numbers must include SBC in the prefix. Case numbers for an attorney’s public discipline can be found on their profile on the State Bar website.

Tip: If you have a number for a recent case without SBC at the beginning, you must add it for a successful search.

Hyphens are not required. For example, SBC-19-O-12345 and SBC1912345 are both valid case numbers for search.

A list of cases will display in reverse chronological order. To view details about a specific case, click the case number in the first column.

You can click the arrow toggles next to each category header to rearrange the order in which the items appear, remove certain categories, or add new ones.

Tip: The Print button here prints only the listing page, not the dockets themselves.

<p>When the selected case is displayed, you can view its Case Information, Parties Involved, Events and Hearings, and Documents using the jump menu that displays on the right.</p>	
<p>To print the docket page, or any sections of the page, click the “Print” button at the top right, above the jump menu.</p> <p><i>Tip: The print function here prints only the listings that display in the docket. Please see below if you wish to print the actual case documents.</i></p>	
<p>Another menu will appear, with all items selected as the default. Deselect any sections you don’t wish to print. Follow the commands on your screen to print.</p>	

Clicking the **Documents** jump link will take you to a list of documents.

To view a document, click the **View Document** button next to the title of the document.

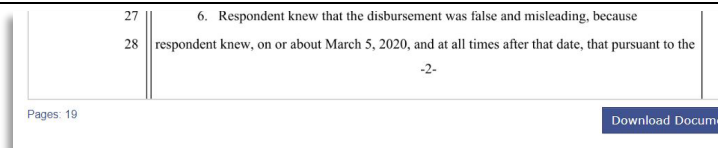


The document will open in a new tab, and the first two pages of the document will display.

To print the first two pages, right-click outside of the document and click **Print** or use the **Files > Print** option in your browser. To return to the case, close the tab.

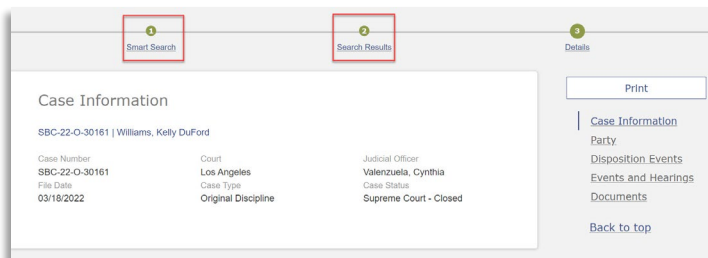


To print the entire document, you must download it. Scroll to the end of the document and click the **Download Document** button. Find the file in your downloads folder to open and print it.

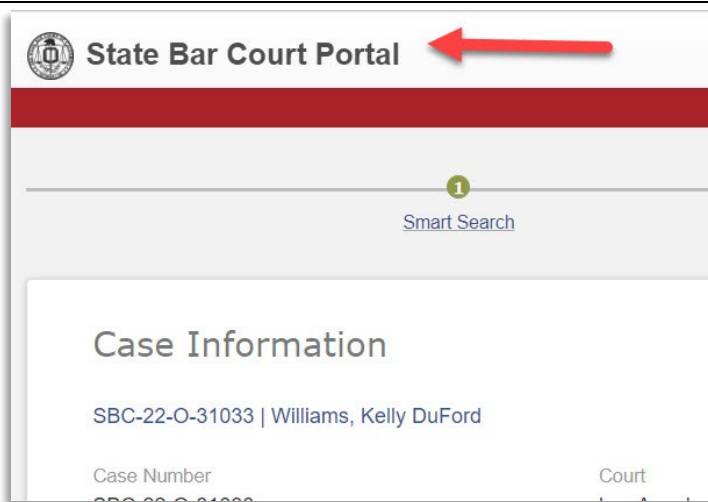




To start a new case search, click the **Smart Search** icon at the top of the portal screen.

To view other cases listed in the Search Results, select the **Search Results** icon.



You can also click the **State Court Portal** logo and seal. It will bring you to a new search page.

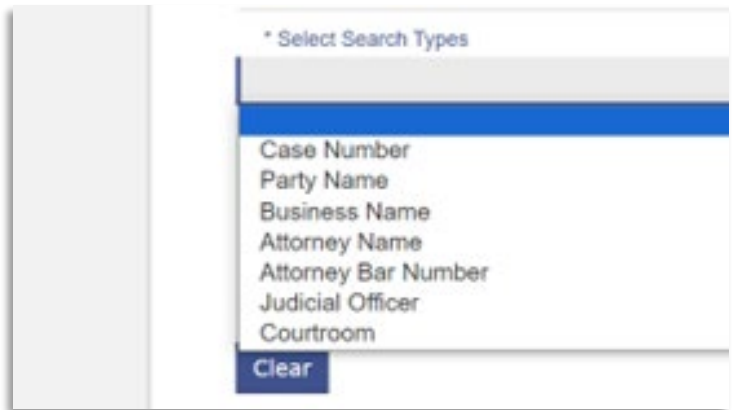
The **“Select Search Type”** field is required. Select the item you’re searching for.

Note: To search by the Respondent, use Party Name.

The Attorney Name and Attorney Bar Number features can be used to search for the Respondent’s attorney, or the Office of Chief Trial Counsel (OCTC) attorney assigned to the case. This selection does not, however, produce results for Respondents.

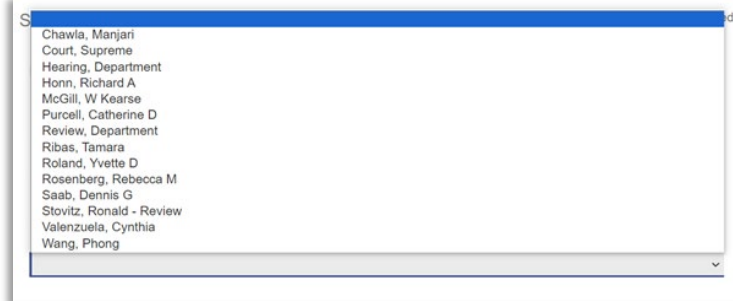
Depending on the type you select, a dropdown menu or new field will display enabling you to narrow your search.

For example, when you search by **Judicial Officer**, a dropdown menu listing the State Bar Court judges will display.



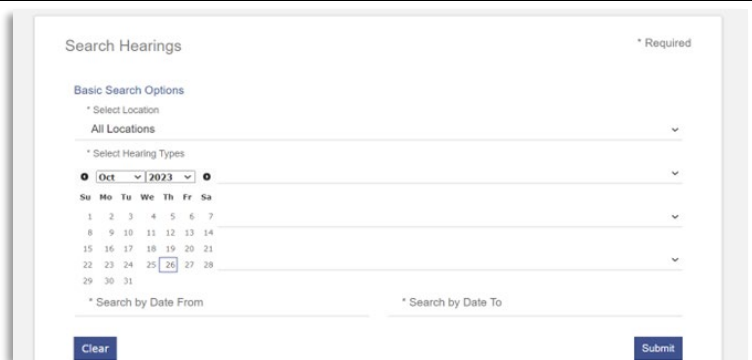
Note: All fields (criteria) are required. You can use them in conjunction with each other to yield specific results.

Note: The Business Name search feature is unavailable.



Note: Supreme Court hearings are not available.

The date range is required. Complete both the **“Search by Date From”** and **“Search by Date To”** entries, either by typing in the dates or using calendar dropdown to select them.



Note: Make sure your Date To is after the Date From field. Errors here will return blank results.

After completing all field entries, click the **Submit** button.

This will bring you to the **Hearing Search Results** page. From here, the scheduled cases will display in a list in reverse chronological order.
