State Bar Court Portal Quick Start

Access is free. There is no need to register or sign in.

How to Access the Portal

Access the portal from the [State Bar Court homepage](#).

For case dockets and records, select **Search for a Case**.

- For public cases filed on or after Feb. 1, 2019, documents are available online.
- For cases filed between 2000 and Jan. 31, 2019, only some documents are available online. To request additional documents, please submit a [written request](#).
- To request certified copies, or for additional information, please see [Public Records & Information](#).

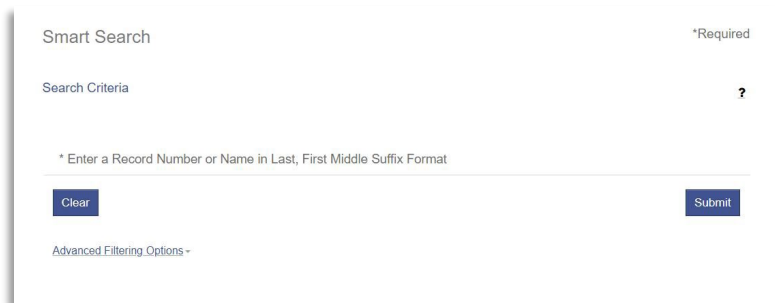
For calendars, select **Court Calendar** (see page 3 of this guide).

The portal will display in a new window.



Search for a Case

Use **“Search for a Case”** to find cases for a specific attorney, respondent, petitioner, or applicant. You can search by **case number (record number), attorney, respondent, petitioner, or applicant name**.



Note: At this time, the advanced filtering options are unavailable.

State Bar Court Portal Quick Start

The name format must be **last name, first name**. The name must be spelled correctly.

Tip: If you are uncertain that you have the correct name, you can use the [Attorney Search](#) feature on the State Bar website, which will offer the option to include similar spellings.

Advanced Filtering Options -

If you know the case number (**Record Number**), you can enter it in the same field as a name.

Tip: For cases filed on or after Feb. 7, 2019, insert **SBC** before the case number, e.g., **SBC-19-0-12345**.

If you have a number for a recent case without SBC at the beginning, you must add it for a successful search.

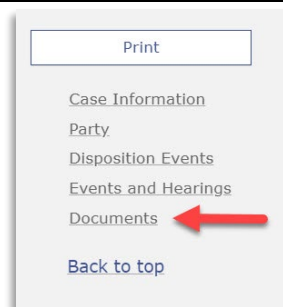

From the list that displays, select a document and wait for it to load in a second tab. The first two pages of the document will display.



State Bar Court Portal Quick Start

To print the first two pages of the document, right-click outside of the document and click **Print** or use the **File > Print** option in your browser.

*Tip: If a document is more than two pages, you must download it to print the entire document. Scroll to the bottom of the document preview and click **Download Document** to download, view, and print it in its entirety.*

To return to the case, close the tab.

State Bar Court Portal Quick Start

Search for a Court Calendar

Use **“Court Calendar”** to find a specific hearing or a specific judge’s calendar. You can search by **case number, party names, business names, names or bar numbers of the attorneys assigned to the case, courtroom, or specific judge.**

To search for hearings or calendars, all fields (criteria) must be completed correctly or in conjunction with each other to yield specific results.

A list of events will appear in chronological order.

Click a case number for details about that case: **Case Information, Party, Events and Hearings, and Documents.**

Tip: To sort results, click the column header.
